Subject: Release of 50% of the funds in favour of Rajarhat-Gopalpur Municipality for execution of development schemes with grant-in-aid made available as Annual Provision under State Finance Commission's Grant during 2006-2007: 2nd instalment thereof.

MEMO

The undersigned is directed, by order of the Governor, to say that the Governor is pleased to sanction payment of a sum of Rs. 43,20,000/- (Rupees forty three lakh and twenty thousand) only in favour of Rajarhat-Gopalpur Municipality for execution of development schemes as per State Finance Commission's Grant during 2006-2007.

2. The amount sanctioned in Para 1 above will be utilised by the Rajarhat-Gopalpur Municipality for creation of assets for improvement of civic services like water supply, solid waste management, drainage, road network, infrastructure development in slum areas etc. priorities of which will be decided by the concerned Urban Local Bodies in consultation with the Ward Committees. This amount must not be utilized to meet any establishment expenditure or maintenance expenditure.

3. The District Magistrate, 24-Parganas (North) is hereby authorised to draw the amount sanctioned herein and disburse the same to Rajarhat-Gopalpur Municipality by transfer credit to their Local Fund Account with the Treasury concerned. The Municipality will prepare the scheme accordingly and include it within their Annual Development Plan and will utilize the said amount for the purpose for which it is sanctioned.

4. The scheme will be executed by the Rajarhat-Gopalpur Municipality in accordance with the N.S.D.P. Guidelines, wherever applicable.

5. The charge is debitible to the heads of accounts under Demand No.39 (Department Code: MA) in the current years Vote-on-Account budget as detailed below
