Subject: **Allotment of fund in favour of Durgapur Municipal Corporation for 'Re-excavation of pond and construction of boundary wall, pathway, box drain and seating arrangement at Faridpur Burning Ghat in Ward No.33' under Development of Municipal Corporations outside KMA Scheme.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.18,42,000/- (Rupees eighteen lakh forty two thousand) only in favour of Durgapur Municipal Corporation for 'Re-excavation of pond and construction of boundary wall, pathway, box drain and seating arrangement at Faridpur Burning Ghat in Ward No.33' under Development of Municipal Corporations outside KMA Scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.

3. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department and the concerned District Magistrate. On receipt of the full utilisation of the amount being sanctioned presently, the balance amount of the project cost may be considered for sanction.

4. A statement of estimate and expenditure incurred should invariably be furnished to State Urban Development Agency.

5. The amount is debitable to the head of account, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-SP-State Plan (Annual Plan and Eleventh Plan)-019-Development of Municipal Corporations outside Kolkata Metropolitan Area-V-Voted-31-Grants-in-aid-GENERAL-02-Other Grants" under Demand No. 39/MA in the current year's vote-on-account Budget.

6. This order issues in exercise of the powers delegated under Finance Department Memo. Nos.700-F.B. dated 31.03.2011 and 1127-F.B. dated 31.05.2011.
