Sir,

With reference to your letter no.776/WBVB/1B-1/84(Vol.XVI) dt.21.01.09 on the subject noted above, I am directed by order of the Governor to say that the Governor has been pleased to accord sanction and release a sum of Rs.9,43,000/- (Rupees Nine lakh forty three thousand) only as grant-in-aid in favour of West Bengal Valuation Board for meeting up the contingencies of the said Board for the month of January, 2009 to March, 2009 of current financial year 2008-2009.

2. The guidelines circulated in Finance Department Memo No.1818-FB dt.31.12.2008 should be duly observed. Actual expenditure should be incurred with due regard to the delegation of Financial Power Rule, 1977.
