**Sub : Payment of Hill Compensatory Allowance to the employees
of Darjeeling Municipality for 2007-08.**

The undersigned is directed by order of the Governor to say that the Governor has been pleased to sanction the allotment of a sum of Rs.28,47,072/- (Rupees Twenty eight lakh forty seven thousand seventy two) only to the employees of Darjeeling Municipality for payment of Hill Compensatory Allowance for 2007-08.

2. The grant-in-aid sanctioned herein above will be drawn by the District Magistrate Darjeeling and disburse the same to the Urban Local Body concerned by transfer credit of the Local Fund Account of the concerned Urban Local Body.

3. The charge is debitable to the head, "2217-Urban Development-05-Other Development Scheme-191-Assistance to Local Bodies, Corporations, Urban Development Authorities, Improvement Boards etc.-NP-Non-Plan-019-Fixed Grants to the Municipal Corporation and other Local Bodies towards salaries of their employees-31-Grants-in-Aid-01-Salary Grants-V" under Demand No.39/MA in the current year's Vote of Account budget (2008-2009).

4. The Utilisation Certificate in respect of the grant sanctioned above should be furnished to the Principal Accountant General(A&E), West Bengal with a copy to this Department, as soon as the amount is drawn and utilised.

5. The Principal Accountant General(A&E), West Bengal/Treasury Officer and other concerned are being informed.
