The authenticated claim of Winter Allowance stating clearly total requirement per annum and 80% of the total requirement in respect of 4 Hill ULBs for the years 2004-05, 2005-06, 2006-07, 2007-08, 2008-09 and 2009-2010.

He is also requested to impress upon the Urban Local Bodies the necessity of submission of the Utilisation certificates of the Winter Allowances released during the last 2 (two) years for further allotment of the aforesaid grant at an early date for necessary action from this end.


