The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs. 1,64,43,000/- (Rupees One Crore sixty four lakh forty three thousand) only to the Urban Local Bodies as per enclosed statement for payment of cost towards Operation & Maintenance of Municipal Water Supply Scheme to each Urban Local Body on ad-hoc basis for the year 2010-2011 during 2011-12.


2. The District Magistrate, is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through the Local Fund Account of the concerned Urban Local Bodies under his jurisdiction.

3. The charge is debitable to the head " 2215-Water Supply & Sanitation-01-Water Supply-101-Urban Water Supply-NP-Non Plan-005-O&M of Municipal Water Supply Scheme-27-Minor Works/Maintenance-V" under Demand No. 39/MA in the current years' vote-on-account budget i.e., 2011-12.

4. The Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note-2 below S.R. 330A of the West Bengal Treasury Rules, Volume-I directly to Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilised.


