Sub : Fixed Grant to the Kolkata Municipal Corporation towards Salaries of their employees for the month of June, 2008.

Sir,

In continuation to the G.O. No.34G/MA/N/C-2/1G-1/2008 dated 22.5.2008, I am directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs.17,97,77,454/- (Rupees seventeen crore ninetyseven lakh seventyseven thousand & four hundred fiftyfour) only to the D.D.O. of the Kolkata Municipal Corporation for payment of salaries to their employees for the month of June, 2008 subject to the following conditions :

1. Grants shall be utilized towards salaries of the employees of the Kolkata Municipal Corporation who are in position and whose appointments have been approved by the State Government as on 1st April, 1986.
2. If on verification any material discrepancies in the number of posts sanctioned and the number of employees in position are detected at any later stage appropriate adjustment in grants to be released subsequently on this account will be made.
3. The grant-in-aid sanctioned herein will be drawn by the Controller of Municipal Finance & Accounts, Kolkata Municipal Corporation in T.R. Form No. 31 after it is duly countersigned by the sanctioning authority.
4. The charge is debitable to the head, "2217-Urban Development-05-other Urban Development Scheme-191-Assistance to Local Bodies, Corporation, Urban Development Authorities, Improvement Boards etc.,-NP-Non-Plan-019-Fixed Grants to the Municipal Corporations & other Urban Local Bodies towards salaries of their employees-31-Grants-in-aid-01-Salary Grants-V" under Demand No. 39/MA in the current year's Vote-on-Account budget i.e. 2008-2009.
5. The Utilisation Certificate in respect of the grants sanctioned herein should be furnished to the Principal Accountant General (A&E), West Bengal, with a copy to the Department in the prescribed proforma as soon as the grant is utilised for the purpose for which it is sanctioned. Utilisation Certificate upto May, 2008 must be produced for further release of fund.
6. The Principal Accountant General (A&E), West Bengal/Pay & Accounts Officer, Kolkata Pay & Accounts Office & other concerned are being informed.
7. This order issues in exercise of the powers delegated under Finance Department Memo No. 2320 FB dated 31.3.2008.
