**Sub : Payment of grant on account of Entertainment Tax Grant to the Kulti Municipality during the year 2007-2008 (5<sup>th</sup> instalment)-Revalidation of the Government Order.**

The undersigned is directed to state that the amount of Rs. 33,25,000/- sanctioned in favour of Kulti Municipality on account of Entertainment Tax Grant (5<sup>th</sup> instalment) during the year 2007-2008 sanctioned in G.O. No. 479G/MA/N/C-2/1G-6/2007 dated 28.3.2008 could not be drawn and utilised in the financial year 2007-2008.

2. In partial modification of G.O. No. 479G/MA/N/C-2/1G-6/2007 dated 28.3.2008 the undersigned is further directed by order of the Governor to say that the Governor is pleased to sanction and release afresh the payment of a sum of Rs. 33,25,000/- (Rupees thirtythree lakh twentyfive thousand) only as Entertainment Tax Grant (5<sup>th</sup> instalment) to the Kulti Municipality for the year 2007-2008 from this financial year's budget i.e. 2008-2009.

3. The fund sanctioned above will be drawn by the District Magistrate who will deposit the same in his P.L. Account and disburse the amount towards payment of electricity dues or any other dues on priority basis and for payment against cost of establishment of the ULB's after clearing outstanding dues mentioned above.

4. The charge will be debitible to the head, "3604-Compensation & Assignment to the Local Bodies & Panchayati Raj Institution-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to the Municipal Corporation & Urban Local Bodies-31-Grants-in-aid-02-Other Grants-V" under Demand No. 39/MA in the current year's Vote-on-account budget.

5. The Grants-in-aid sanctioned in para-1 above is for general purpose/non salary grant which is released to the Urban Local Bodies for particular purposes of the liquidation after reconciliation of outstanding dues of CESC/WBSEB/HUDCO if any on priority basis and for payment against cost of establishment after clearing the dues of aforesaid agencies. Utilisation Certificate is to be furnished by the ULBs in terms of Note-2 below SR. 330A of the Treasury Rules, West Bengal Volume-I to Principal Accountant General (A&E), West Bengal with a copy to this Department.

6. This order issues with the concurrence of the Finance Department (vide their U.O. No. 99 Gr-R dated 27.6.2008).
