2. The Grants-in-aid sanctioned herein above will be drawn by the concerned District Magistrate and he will deposit the same in his P.L.A/c. and disburse as salaries to the existing regular employees of the Urban Local Bodies as against sanctioned strength from his end under this jurisdiction.

The charge is debitable to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-019-Fixed Grants to the Municipal Corporation and Other Local Bodies, towards salaries of their employees-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA" in the current year's i.e. 2009-2010 Vote-on-Account provision..

The Utilisation Certificate in respect of the grants to be drawn by the concerned Urban Local Bodies should be furnished in the prescribed form direct to the Principal Accountant General(A&E), West Bengal, with a copy to the undersigned, as soon as the amount is drawn and utilised, submission of Utilisation Certificate upto June, 2009 will be required for further grants in this respect.
