Sir,

I am directed by order of the Governor to say that the Governor has been pleased to accord sanction and release to the payment of Rs.25,41,65,000/- (Rupees Twenty five crore forty one lakhs sixty five thousand) only to the Kolkata Municipal Corporation under "Direct Payment Procedure" for implementation of the Kolkata Environmental Improvement Project (Asian Development Bank assisted programme under Loan No. 2293-IND).

2. The said amount has been released in favour of the State Government as Additional Central Assistance as 100% loan on Back to Back basis during the year 2010-2011 for the said externally aided project and has been credited to the accounts of the Controller of Aid Accounts & Audit by the Department of Expenditure, Ministry of Finance, Plan Finance-I Division, Government of India vide their sanction letter no. F. No. 53(2)/PFI/2010-535 dated 07.09.2010, F. No. 53(2)/PFI/2010-600 dated 22.09.2010, F. No. 53(2)/PFI/2010-619 dated 24.09.2010, F. No. 53(2)/PFI/2010-700 dated 20.10.2010, F. No. 53(2)/PFI/2010-758 dated 01.11.2010, F. No. 53(2)/PFI/2010-818 dated 18.11.2010, F. No. 53(2)/PFI/2010-845 dated 26.11.2010, F. No. 53(2)/PFI/2010-976 dated 30.12.2010, F. No. 53(2)/PFI/2010-1024 dated 07.01.2011, F. No. 53(2)/PFI/2010-1267 dated 23.02.2011, F. No. 53(2)/PFI/2010-1335 dated 10.03.2011 and F. No. 53(2)/PFI/2010-1446 dated 25.03.2011 towards the adjustment of the rupee equivalent of fund dues from the State Government in connection with the said project.

The amount is not to be paid in cash but is to be adjusted by per contra credit to the accounts for the year 2011-2012 as 100% loan on Back to Back basis for implementation of the project.

3. The above adjustment is to be made in the current years Vote-on-Account budget for the year 2011-2012 under Demand No. 39 and Departmental Code 'MA' in the following manner:
