Sub : Payment of grants on account of 'Relief-on-Pension' for the Municipal Pensioners
at the revised rate to the pensioners of Jhalda Municipality during the year 2004-05
- Revalidation of the Government Order.

The undersigned is directed to state that an amount of Rs.2,86,800/- (Rupees two lakh eighty six thousand and eight hundred) only sanctioned in favour of Jhalda Municipality on account of 'Relief-on-Pension' during 2004-2005 in G.O.No.98G/MA/N/C-2/1G-4/2003 dated 04.10.2004 could not be drawn and utilised in the financial year 2004-2005.

2. In partial modification of G.O.No.98G/MA/N/C-2/1G-4/2003 dated 04.10.2004, the undersigned is further directed by order of the Governor to say that the Governor is pleased to sanction and release afresh the payment of a sum of Rs.2,86,800/- (Rupees two lakh eighty six thousand and eight hundred) only as Relief-on-Pension for the pensioners of Jhalda Municipality for the year 2004-2005 sanctioned during the year 2004-2005 from this financial year's vote-on-accounts budget i.e. 2008-2009.

3. The fund sanctioned above will be drawn by the District Magistrate who will disburse the amounts to the concerned local body by transfer credit through Local Fund A/c. of the concerned ULB in favour of the pensioners who have received the P.P.O. for drawal of their pension.

4. The charge will be debitible to the head, "2071-Pensioner and Other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension to the employees of Local Bodies-04-Pension/Gratuities-V" under Demand No.18/Finance (Audit) Department in the current year's vote-on-account budget.

5. Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal Volume-I to Principal Accountant General (A&E), West Bengal.

6. This order issues with the concurrence of Finance Department (vide their U.O. No.94 Gr.'R' dated 25.06.2008).

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
