The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs. 1,20,00,000/- (Rupees one crore twenty lakh) only to the Urban Local Bodies as detailed in the enclosed statement for construction / extension / renovation of their Office Buildings, as the case may be as per representations received.

2. The District Magistrates concerned are authorised to draw the amount sanctioned in para 1 above in T.R. Form No.31 and to disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned. The Urban Local Bodies will execute the scheme after vetting the plans and estimates by the Municipal Engineering Directorate.

3. The Utilization Certificate in terms of S.R.330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Bodies to the Principal Accountant General(A & E), West Bengal with copies endorsed to this department, the concerned District Magistrates as well as the State Urban Development Agency.

4. The fact of drawal / non-drawal of the grant by the concerned local bodies, as may happen, should be reported to this Department immediately. Further fund, if at all, can be released only on receipt of utilization certificate of earlier and this allotment from the Urban Local Bodies.

5. The amount is debitabale to the head of account, "2217-Urban Development-80-General-800-Other Expenditure-SP-State Plan(Annual Plan & Eleventh Plan)-002-Construction of Municipal Buildings-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No. 39/MA in the current year's vote-on-account Budget.

6. This order issues in exercise of the powers delegated under Finance Department Memo. No.2500-F.B. dated 31.03.2009.

7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.
