I am directed by order of the Governor to say that the Governor has been pleased to accord sanction and release to the payment of Rs. 98,75,000/- (Rupees Ninety eight lakhs seventy five thousand) only as loan component of Additional Central Assistance to the Kolkata Municipal Corporation under "Reimbursement Procedure" for implementation of the Kolkata Environmental Improvement Project (Asian Development Bank assisted programme under Loan No. 1813-IND) in terms of Department of Expenditure, Ministry of Finance, Plan Finance-I Division, Government of India sanction letter no. F. No. 53(1)/PFI/2011-1172 dated 28.12.2011 and F. No. 53(1)/PFI/2012-660 dated 27.09.2012.

2. The Municipal Secretary, Kolkata Municipal Corporation is hereby authorized to draw the amount mentioned in para 1 above in TR Form No. 31 from the Kolkata Pay & Accounts Office after it is duly countersigned by the Sanctioning Authority.
