  07. Operation expenses viz. expenses on Bank/Post Office charges, charges relating to business correspondence by Bank, use of common service center.
  08. Stationery related to computational process/MIS.
  09. One time augmentation of computational facilities at the ULB level and one time expenses for almirah for record-keeping and functional furniture.
