(62 ULBs covered under NULM) Municipal Corporation/ Municipality**Sub : Training proposals under ‘Employment through Skill Training & Placement’****(EST&P) component of NULM**

Sir,

As you are well aware National Urban Livelihood Mission (NULM) has replaced Swarna Jayanti Sahari Rojgar Yojana (SJSRY) as the flagship urban poverty alleviation programme and is being implemented in the State from 1st April, 2014. An important component of NULM is ‘Employment through Skill Training & Placement’ (EST&P) which aims at skilling the unskilled urban poor for generation of sustainable livelihoods and improve their standard of living.

The choice of training institutes, as you would agree, plays a pivotal role for effective delivery of skill training programmes and hence, sufficient precaution may kindly be taken in this regard. In terms of NULM Guidelines rigorous selection process of training institutes under NULM is in progress and a fresh list of such empanelled training institutes will be communicated to you after the selection process is complete. In view of it, it has been decided that till such time this fresh list of trainers under NULM is finalized, the training providers for training under NULM may be selected from the list of training institutes that was short listed by a State Level Screening Committee under SJSRY, a copy of which is already available with the ULBs.

The yearly target allotted for 2014-15 under the different components of NULM including EST&P has already been communicated to you. For achieving the allotted target, you are requested to sponsor and submit adequate number of training proposals during the first half of 2014-15 (proportionate to 1st & 2nd quarter of 2014-15 target) after giving due weightage to the income earning potential to each of the proposed courses. In this regard it may be relevant to mention that all training proposal/s submitted by you, if any, under erstwhile SJSRY programme may be treated as cancelled and re-submitted under NULM as fresh proposal, if those are found relevant.

However, while proposing a training institute for the skill training, competencies of the skill training institute in terms of trainer/faculty, adequate infrastructure and job placement performance during the last 2-3 years are to be taken into consideration.
