In pursuance of the decisions of the Ministry of Social Justice and Empowerment, Government of India adopted in the meeting at New Delhi to review the progress of action for complete elimination of insanitary latrines and rehabilitation of manual scavengers on the 19th February, 2013, the Governor is pleased hereby to designate the State Urban Development Agency as the State Level Nodal Agency, and to appoint Shri Amit Dawn, Executive Engineer, Municipal Engineering Directorate and Project Engineer, State Urban Development Agency as the Nodal Officer to co-ordinate and monitor the work of survey of manual scavengers in 125 Urban Local Bodies (excepting 2 in Dakshin Dinajpur out of 127 ULBs in this State where Pilot Survey has been completed).
