Sealed Tenders in printed form as specified are hereby invited by the Executive Engineer, 24 Parganas Division II, Municipal Engineering Directorate, Bikash Bhavan, Salt Lake, Kolkata for **“Supplying fitting & fixing of decorative light poles along with all accessories within different Municipalities”** as per Annexure - I

T. and S.T. etc. The working contractors whose performances are not satisfactory will not be allowed to participate in this tender.
4. Printed form in which tender is to be submitted : West Bengal Form No. 2911 (ii) including up-to-date Corrigenda and addenda as per order of Government.
5. Price per set of tender documents : Tender documents can be obtained on cash payment of non-refundable fee Rs300/-for each Group of A,B,C,D,E,F,G,H,I,J,K,L,M,N,O,P,Q,R as mentioned attached in Annexure -I from the Office of the Executive Engineer,24 Parganas Division II, M.E.Dte.

Application seeking permission for purchasing tender documents should be accompanied by the attested photocopies of all credentials, e. g., work order, payment certificate, and completion tender documents. Certificate and valid documents alongwith the attested photocopies of PAN card, up-to-date clearance certificates for I. T., P. T. and S. T. and certificate for VAT registration, if any. In absence of any of these documents, the application will not be considered for permission. Attestation of all above documents shall have to done from a notary.

10. Mode of issue of tender papers : Tender papers will be issued from the Office of the Executive Engineer, 24 Parganas Division II, M.E.Dte. One applicant will be allowed to participate for maximum 3(three) groups of work
11. Mode of payment of completed works : Payment of completed work/works will be made from State Urban Development Agency, on the value of work done recommended by the executive Engineer, 24 Parganas Division II, M.E.Dte.

It is obligatory under IE rules that all electrical installation works shall be executed under qualified electric supervisor holding electrical supervisor certificate of competency granted by the state licensing board. The tenderers are bound to furnish following details with quotation paper.

- Name of work
- Name of Electrical Engineer / Supervisor
- Qualification of Electrical Engineer / Supervisor (i.e. the part in which Electrical Supervisor's certificate of competency has been issued by the licensing board)
- Registration No. of Supervisor
- Next date of renewal of Supervisor's licence
- A contractor's licence no.
- All works shall be executed in adherence to the IE rules

If the Office of the Executive Engineer, 24 Parganas 24-Pgs Division II, Municipal Engineering Directorate, Bikash Bhavan, Salt Lake, Kolkata, happens to be closed on the date of receiving and opening tenders these will be received and opened on the next working day at the time and venue as mentioned above without any further notice.




