Sealed Tenders in printed form as specified are hereby invited by the Executive Engineer Burdwan Division, Municipal Engineering Directorate, Purta Bhavan, 5<sup>th</sup> floor, Sadarghat, Sreepalli, Burdwan for "Supplying, fitting & fixing of decorative light poles along with all accessories within different Municipalities" as per Annexure – I

In absence of any of these documents, the application will not be considered for permission. Attestation of all above documents shall have to done from a notary.

- c. Qualification of Electrical Engineer / Supervisor (i.e. the part in which Electrical Supervisor's certificate of competency has been issued by the licensing board)
- d. Registration No. of Supervisor
- e. Next date of renewal of Supervisor's license
- f. A contractor's license no.
- g. All works shall be executed in adherence to the IE rules

If the Office of the Executive Engineer, Burdwan division, M.E.Dte, Purta Bhavan, 5<sup>th</sup> floor, Sadarghat, Sreepalli, Burdwan happens to be closed on the date of receiving and opening tenders, these will be received and opened on the next working day at the time and venue as mentioned above without any further notice.

Tenders in sealed cover containing all the documents must be superscribed with the name of the work/s, Group No. and tender notice no. Tenders will be opened in presence of the participants or their authorized representatives who will intend to be present at the time of opening.
