Sealed Tender in printed form as specified, are hereby invited by the Superintending Engineer, East Circle, Directorate of Municipal Engineering, Bikash Bhavan (1st floor), Salt-lake, Kolkata – 700 091 for the following works from the eligible contractors as per particulars below and will be received by him upto the time specified herein in his office.

1. Name of the work : **Renovation of Bituminous Road starting from Dhakhineswar Temple Gate to Adyapith Temple via Rani Rasmoni Road, Ramkrishnadeb Road, R.N.Tagore Road and D.D.Mondalghat Road near Adyapith Temple**
2. Name and address of the Executive Engineer : Executive Engineer, 24 Parganas Division-I, Municipal Engineering Directorate, 7,K.B.Bose Road, Barasat, Kolkata-700124
3. Estimated Value of work : **Rs. 1,88,75,426.00**
4. Earnest money : 2% on estimated amount put to tender.
Earnest money to be paid in favour of the Executive Engineer, 24 Parganas Division-I, M. E. Dte. in the form of Bank Draft/Pay order drawn on any nationalized Bank within West Bengal and must accompany with the tender, without which the tender will be summarily rejected.
5. Eligibility to Purchase and submit Tenders. : The intending Tenderer, PWD enlisted (1st class) or bonafide outsider or working contractors under this Directorate who have successfully completed **Mastic Asphalt Road works** amounting to **Rs. 75,50,170.00 in a single contract** within last 5 (five) years from the date of this Tenders and also having upto date clearance certifications of P.T, pan card and VAT.
The Tenderer who were allowed to purchase Tender papers for last 3 (three) Tenders of this circle but did not participate in any two of the such tenders, they are not eligible to participate in this Tender and working contractors whose performances are not satisfactory will not be allowed to participate in this Tender.

In absence of any of these documents the application will not be considered for permission.

Deduction of CESS @ 1% : CESS @ 1% of the cost of construction work would be deducted from the bills additionally apart from other statutory deduction like VAT/ IT etc. as per notification no. 1182 – IR dt. 20.09.05 of Labour Department. Rate quoted by the tenders shall be deemed to have made the provision on his/ her own accordingly.

If the office of the S.E. (E), M.E.Dte. happens to be closed on the date of receiving and opening of Tender, these will be received and opened on the next working day at the same time & venue without any further notice.

Tender in sealed cover containing the entire Tender must be superscribed with the name of the work and Tender Notice No. Tender will be opened in presence of the participants or authorized representatives who intend to be present at the time of opening.

Tender submitted in any form other than the Tender documents issued in favour of Tenderer are liable to be rejected. Tender documents with missing pages or schedule items will be disqualified and it will be the Tenderer responsibility to point out, any short coming in documents furnished well before the date of submission for needful action, if any by the S.E. (E), M. E. Dte.


