9. In case of bundh, holiday etc. falls on the schedule date as enumerated above, the same may treated just after the next working day .

10. The contractor whose tender is accepted will be required to furnish security deposit for due fulfillment of his amounting to 10% (ten per cent) of the total value of work actually done.The earnest money shall be converted as part security, the balance S.D will be deducted from each progressive bill.

11. If any tenderer withdraw his tender before its acceptance or refusal from the date of opening of tender, without giving any satisfactory reasons, he shall be disqualified for submitting any tender to thisDeptt. for a minimum period of one year. The corresponding earnest money also be forfeited.

12. Contractor shall be presumed to have inspected the site of works before submission of tender.

13. Conditional tender will be nullified by the tender accepting authority.

14. All corrections in the tender are to be signed and dated by contractors. Illegible, irregular, incomplete tenders are liable to rejection.

15. The power of attorney which may be characterized as agency agreement will not be accepted without specific order of the Govt.

16. Intending tenderer must declare if there is any other firm or firms having common or identical interests with them.

The intending Tenderer(s) may see tender documents and other relevant particulars (if any) during office hours in the office of the undersigned. Application (in duplicate) along with the proof of their credentials for satisfactory completion of similar nature and value of works as desire in proper form and valid certificate of up-to-date clearance of P.T, S.T & VAT, failing which no tender paper will be issued. Intending Tenderers shall apply and obtain tender papers in advance to guard against any difficulties due to possible absence from the head quarters of the concerned Officer. Earnest money to be deposited in the form of Bank Draft / Pay Order only from any Nationalized Bank and to be drawn in favour of the Executive Engineer, Berhampore Division, Municipal Engineering Directorate and will be acceptable on condition that collection charge (Bank charge) of draft if required are to be paid by successful tenderer.
