Sealed Tenders in printed form as specified are hereby invited by the Executive Engineer, 24 Parganas Division-II, Municipal Engineering Directorate, Bikash Bhawan, South Block(1st Floor), Salt Lake City, Kolkata-700 091 for “**Supplying, fitting & fixing of Decorative Light Poles along with all accessories along Jessore Road from Airport Gate No:- 1 to Patipukur Railway underpass**” as per Annexure – I.

In absence of any of these documents, the application will not be considered for permission. **Attestation of all above documents shall have to be done from a Notary.**
