Dte, Burdwan division, Burdwan. The intending tenderers will also have to produce attested copies of PAN Card in respect of Income Tax, upto date Sale Tax Clearance Certificate or VAT Registration Certificate, valid Professional Tax Clearance Certificate (Application will not be allowed) and License from the concerned Registration Officer under contract and labour (Regulation and Abolition Act. 1979) for being entitled to receive the tender paper. One percent Cess will be recovered from the bill in addition to other recovery.
